Global Software Certifications



Certified for Common Criteria (ISO 15408)

<u>Common Criteria</u> is an internationally recognized independent security certification recognized by governments in 31 countries across Europe, Australasia, Asia and North America. <u>Blancco Drive Eraser</u> 6.9.1, <u>Blancco Drive Eraser</u> 7.3.1 and <u>Blancco File Eraser</u> 8.2 are all Common Criteria certified.

Asset Disposal & Information Security Alliance (ADISA)

The ADISA Research Centre is the test laboratory operated by ADISA Certification Limited where software overwriting products can have claims made about their effectiveness verified. Blancco's SSD Erasure Method passed tests against ADISA Test Level I (attack using standard COTS forensic tools and techniques) and Test Level Il (attack using standard intrusive/destructive testing tools designed to read data directly off of a chip) testing.



Blancco Drive Eraser 7.7.1 is certified to the newly launched IEEE 2883 Compliance, under the ADISA PA schema. Blancco Driver Eraser has passed the Product Assurance test for NIST 800-88 compliance, and is one of the few certified products with IEEE 2883 Standard on Data Sanitization in the market and achieved Assurance Level 5.

Blancco Eraser for Apple Devices v5.4.2 has passed the ADISA Product Claim Test (PCT) Level 1 test certification, the first certification for this product and the only certification for embedded storage media (media tested: Apple Macbook Pro M2 – macOS Sonoma 14.7 / algorithm used: Apple iOS Erasure)

Additionally, Blancco Mobile Diagnostics & Erasure has been certified to sanitize data on mobile devices against ADISA Test Level I, and Blancco Driver Eraser has been certified to sanitize data against ADISA Test Level II.

Blancco WinEraser has been certified under ADISA Test Level 2 for its ability to render data irretrievable on SSD and NVMe media, and has achieved Assurance Level 4.
